

RESOLUTION 2018-09

A RESOLUTION ADOPTING THE FINAL BUDGETS
OF THE SPRING LAKE IMPROVEMENT DISTRICT
FOR FISCAL YEAR 2019

WHEREAS, the Spring Lake Improvement District (hereinafter "District") was created by the Florida Legislature and codified in Chapter 1971-669, Laws of Florida, as amended by Chapter 2005-342, Laws of Florida, as amended by Chapter 2012-264, Laws of Florida, pursuant to the authority granted therein and;

WHEREAS, the District Manager has heretofore prepared and submitted to the Board, for approval, the District's proposed General Fund, Water Fund, Wastewater Fund, and Lot Mowing Fund Budgets for the ensuing fiscal year; and


WHEREAS, a public hearing had been held on August 8, 2018, at which members of the general public were accorded the opportunity to speak prior to the adoption of the final budget;
