What Is SLID?

Over the years, most people have simply referred to the Spring Lake Improvement District as SLID. Created by a Special Act of the State Legislature in 1971, it is a unit of government similar to a municipality. The exception is that the District does not have authority over land use, zoning, development codes, police, or fire. Throughout Florida, Special Districts were established to promote development. Coral Ridge Properties, which was a subsidiary of Westinghouse Electric, took the leadership role in the development of Spring Lake.

Throughout the '70s, Spring Lake grew and developed. On July 26, 1980 the Spring Lake Golf Course marked its grand opening. That same year the Community Center remodeling was completed, and has remained in its current location since that time. In addition to Pine Breeze Park, where the community center is located, the District also maintains a park in Village I, Lakeside Park, Russ Ankrom Park, and both a park and boat ramp at Arbuckle Creek.

The District is responsible for the construction, operation and maintenance of the Water Management System for drainage and flood control. All permitting comes from the South Florida Water Management District. It is also responsible for the supply of potable water, mosquito control, street lighting, lot mowing and the operation and maintenance of recreational facilities.

Spring Lake was originally designed to have gravity flow drainage through water control structures that go west to east, to the pump station. The system drains approximately 3,324 acres, 200 acres of canal surface, and 17.1 miles of canal network. This system has worked exceptionally well for the community until a lawsuit was filed by a property owner east of the pump station. The District has been under a pumping injunction for the past several years (see injunction article) as a result of this owner's litigation.

There are five commissioners who are elected by the voters. Three are elected by the landowners (one vote for each lot) and two are elected by popular vote. They meet the second Wednesday of each month at 3:30 p.m. in the District Offices.

The District Offices are located at the corner of Spring Lake Boulevard and Rt. 98 and are open to the public. A drive-up window allows residents to personally pay their monthly water bills or seek information. The office has the capacity to operate emergency services and to be headquarters for emergency personnel. The normal business hours are weekdays, 8 a.m. to 4 p.m., with on-call emergency staff 24 hours.

Throughout the upcoming months we will be writing stories about numerous facets of SLID, from its history to its current status. There is a lot to learn about SLID and your community and we look forward to sharing it with you.

The 12 Hours Of Sebring

The Sebring Regional Airport and International Raceway have been neighbors to Spring Lake since the founding of our community. Both are home to one of the most famous races in the world, The Mobil 1 Twelve Hours of Sebring. The first race was held on New Year's Eve day in 1950 and lasted six hours. Two years later, the race was moved to March and promoted by Russian-born Alec Ulmann, who was an internationalist and founder of the Sports Car Club of America. Ulmann built the competition, bringing in world-famous drivers like Sterling Moss of England, World Champion Juan Fangio of Argentina, and Indy 500 winners like Bob Sweikert. He also brought in factory teams from Ferrari, Porsche and Jaguar, boasting drivers and crews from

all over the globe. In ensuing years, competitors have come from all seven continents. Nobility and Hollywood actors like Steve McQueen and Paul Newman have run the historic circuit.

The crush of fans has grown as well, from a few thousand at the first event, to an estimated 170,000 last year. The race has drawn international television coverage, becoming a staple of the Speed Channel. America's oldest and most prestigious sports car endurance race has become a preview of the famous 24 Hours of Le Mans. The winning manufacturer at Sebring has gone on to win Le Mans in seven of the past eight years.

Gates open on Wednesday, March 14 and remain open 24 hours a day through Saturday's 12-hour endurance classic.

You Be The Judge

For the last several years most residents in Spring Lake have been confused, angry, disappointed or concerned about the injunction that the local courts have placed on the operation of our pumping station. There is no doubt that this litigation has cost our community monies that were better spent elsewhere. Just prior to the lawsuit, after years of planning, a new Community Center was going to be built. That project has been on the back burner since litigation began. What exactly are the facts of this case? What exactly has the court told Spring Lake? What exactly must we do in the future? Here are the applicable facts as presented by our attorneys to Circuit Judge Ellen Masters in a memorandum of law dated Oct. 6, 2006. It formed the basis of our request to the court, at a Dec. 1 hearing, for the injunction granted by Judge Langford to be modified or lifted.

The memorandum reads: "Spring Lake was created in 1971 by a Special Act of the Legislature of the State of Florida. Concurrently, in 1971, Circuit Court Judge Clifton Kelly approved the incorporation of Spring Lake under Chapter 298 of the Florida Statutes. Spring Lake then prepared a Plan of Reclamation and submitted it to the court. On May 31, 1973, Judge Kelly approved the bond issues for assessments to be levied against all the property within Spring Lake's boundaries. South Florida Water Management District (SFWMD) issued Permit #5897 on Dec. 13, 1973 to Spring Lake to construct and operate a 260,000-gallon per-minute pumping station, which would discharge overflow waters into Lake Istokpoga via Arbuckle Creek. Over 3,300 acres of wetlands were reclaimed by draining water through canals and the pumping station, which Spring Lake constructed in 1974. The final surface water management permit was granted by SFWMD on May 11, 1978, authorizing the plan. In the late 1970s construction of many homes and development of properties in Spring Lake was fully under way when new environmental regulations made approximately 500 acres of land inappropriate for development.

"In 1985, Florida National Properties sold the 500 acres

of land deemed inappropriate for development in three separate but contiguous locations to Central Southern Properties. In 1986 they auctioned off the 500 acres and Sandy Tyrell, with record notice and presumed full knowledge of the flooding issues, purchased 38 acres of the property that had been deemed inappropriate for development.

"It is unclear how Sandy Tyrell was able to obtain building permits for this property. However, what is clear is that Spring Lake, under its authority from SFWMD's permit, was required to turn on one pump when the water in the canals reached elevation 37.5 feet, and a second pump when the water reached 38.5 feet. Since 1974 much of the water that comes from the pump station flows over the majority of the Tyrell property, as planned and expected."

Attorney Kevin Ashley has represented Tyrell and has been successful in convincing the courts that Spring Lake has no legal right to put water on her property. Over the past several years the courts continue to tell Spring Lake that what has worked since the inception of our community is no longer allowed and now is under injunction. What was permitted by SFWMD is not valid and we should find a new solution. What has always been wetlands and not suitable for development should now be protected by the courts, regardless of the impact it has on the rest of our community.

With the help of the State of Florida Attorney General's Office and a study being conducted by our engineering firm, the Board of Commissioners will be looking at future options to resolve this problem.

Judge Langford and Judge Masters have ruled against Spring Lake and have placed and upheld a severe injunction on the operation of our pumping station. We are only allowed to pump 15 minutes per hour, up to 90 minutes per day. As we saw during *Ernesto*, that will not protect our community.

You be the judge.

Notice Of Meetings

The Board of Supervisors of the Spring Lake Improvement District will hold their meetings at the District Office, 115 Spring Lake Blvd., Sebring. The meetings will be held the second Wednesday of each month, beginning at 3:30 p.m.

Any person requiring special accommodations at these meetings because of a disability or physical impairment should contact the District Office at (863) 655-1815 at least five calendar days prior to the meeting. Meetings may be continued at a later date and time, which will be announced at the meeting.

Each person who decides to appeal any decision made by the Board with respect to any matter considered at the meeting is advised that that person may need to ensure that a verbatim record of the proceedings is made, including the testimony and evidence upon which such appeal is to be based.

Lot Cleaning To Begin

Since the hurricanes of several years ago, many vacant lots still have large trees and limbs lying on the ground. The Improvement District, charged with mowing these lots, does not have jurisdiction over the lot owners to make them clean their property. The Spring Lake Property Association, which enforces the deed restrictions in our community, has the legal authority and has paved the way for expanded lot cleaning.

The Association Board voted to communicate with all lot owners and inform them that their lots are to be cleaned so proper mowing can take place. If the owner refuses to comply, the Association will place a lien on their lot.

The Association has secured bids and hired a firm to cut the trees and limbs. Spring Lake Improvement District has committed to use its equipment and manpower, as needed, to assist. This is a major cooperative venture that will certainly upgrade the aesthetics of our entire community. Thank you to both the Association and District Boards for working together on this important project.

The process includes lots in Villages I through VI, extending two lots in either direction from an existing dwelling. Please contact the Property Association if you want to notify them of lots that need to be part of this program.

Lorida Volunteer Fire Department

For many years, the Spring Lake community has been protected by a group of trained, committed and valuable individuals. Located on Rt. 98, the department responds to fires and emergencies on a regular basis. Last year they responded to 225 calls and personnel worked more than 2,250 hours on these calls.

The Lorida Fire District covers 256 square miles. There are 10 vehicles that average close to \$800 in fuel bills alone. There are seven state-certified firefighters and three CPR instructors. Other training to increase the level of expertise is available and the department is committed to taking advantage

of these programs as funds become available.

As an all-volunteer organization the department conducts various fund-raising activities throughout the year. In future editions of this paper we will be highlighting this very important facet of our community and learning how all of us can help support the department.

No Boil Orders Here


Spring Lake residents are very fortunate to have the quality water system that has been in place for many years. When you read about the number of boil orders that other communities have, you begin to appreciate our water plant. Drawing from two artesian wells drilled 1,000 feet deep into the Florida aquifer, Spring Lake's water plant has long been recognized for providing an abundance of safe, cool, clear water to its residents.

In 1971, the first water plant was constructed and had 85,000 gallons in above ground storage, and a design flow of 150,000 gallons per day. Water mains and service lines were first installed in Village I and continued installation occurred as the other villages developed.

In 1983, due to projected growth, a new water plant was

designed that had above ground storage of 250,000 gallons and a flow of 500,000 gallons per day. As the community expanded, another 400,000-gallon tank was added. Today, Spring Lake has a design flow of nearly one million gallons per day!

With one of the lowest usage rates in Central Florida, \$1.43 per 1,000 gallons, Spring Lake is positioned to provide water to countless new customers in the future, and ensure the continued growth of our community. In spite of the size and scope of our water plant, only two people oversee operations. Greg Gretz has been with the District for nearly 25 years and is our water department supervisor. He is assisted by J.R. Clarke, who has been with us for six years. Both of these men are very committed to providing quality water and services to our community.
